-Current situation of agriculture and policy research

+Achievements

- Establishment of number of research institutes and centers involving in agriculture and forestry research. (NAFRI, NIER, ERIT, ERI, etc.).
- > Number of research findings and publications related.
- ➤ Employment of these research findings for formulation and implementation of agriculture and forestry development policy, strategy and action plan as well as NSEDP.

+Limitation

- ➤ Lack of strong coordination network among research institute and centers involving agriculture and forestry research.
- > Lack of efficient research strategy and action plan supporting development of that sectors
- ➤ Lack of efficient mechanism to mainstream research finding into process of policy formulation and implementation.
- ➤ Many small scale, very specific and isolated research topics.
- > Many overlapping research topics.
- > Some of research topics do not development priority.
- > Limited financial support and human capitals.

- -Discussion how to strengthen agriculture and forestry research to support policy formulation and implementation.
 - +Establishment of the national and sectorial research network to support national, sub-national and sectorial policy formulation and implementation with strong focal point for carrying out following main tasks:
 - Capacity building for research institutes and centers.
 - > Funding mobilization.
 - Managing and mainstreaming research findings into policy formulation and implementation process.
 - +Development of a national (updated) and sectorial research framework and action plan to support policy formulation and implementation.
